DIRECTIONS

From Schuylkill Expressway Philadelphia:

- 1. Head north on I-76 W (about 16 mi)
- 2. Take exit 327-328A-328B for US-202 W toward US-422 W/King of Prussia/W Chester/Pottstown
- 3. Take exit 328A on the left to merge onto US-202 S toward W Chester (about 8 mi)
- 4. Take the exit toward PA-29 S/Malvern
- 5. Turn right onto W Swedesford Rd
- 6. Take the 1st right onto PA-29 S/S Morehall RD
- 7. Take the 1st right onto Lindenwood Drive
- 8. Make first right into Valleybrook Corporate Center
- 9. Bear right and follow sign to 101 Lindenwood Drive into office complex

From Route 100 Pottsville:

- 1. Head south on PA-100 S toward N State Street
- 2. Merge onto US-422 E via the ramp to King of Prussia
- 3. Keep right at the fork, follow signs for US-202 S/W Chester and merge onto US-202 S
- 4. Take the exit toward PA-29 S/Malvern
- 5. Turn right onto W Swedesford Rd
- 6. Take the 1st right onto PA-29 S/S Morehall Road
- 7. Take the 1st right onto Lindenwood Drive
- 8. Make first right into Valleybrook Corporate Center
- 9. Bear right and follow sign to 101 Lindenwood Drive into office complex

From Delaware and South:

- 1. Take I-95/Christiana/Wilimngton
- 2. Merge onto DE-1 S
- 3. Take exit 165B to merge onto I-95 N toward I-295/I-495/Wilmington/Philadelphia 8.8 mi
- 4. Take exit 8 to merge onto US-202 N/Concord Pike toward W Chester
- 5. Continue to follow US-202 N....Entering Pennsylvania
- 6. Merge onto US-202 N/US-322 W/W Chester Bypass via the ramp to Paoli/Downingtown
- 7. Continue to follow US-202 N 10.5 mi
- 8. Take the PA-29 S exit toward Malvern
- 9. Turn right onto PA-29 S/S Morehall Rd
- 10. Take the 1st right onto Lindenwood Drive
- 11. Make first right into Valleybrook Corporate Center
- 12. Bear right and follow sign to 101 Lindenwood Drive into office complex

From Schuylkill Expressway Philadelphia:

- 1. Take US-30 Bypass East (approximately 18. mi)
- 2. Keep right at the fork, follow signs for US-202 N/King of Prussia and merge onto US-202 N
- 3. Take the PA-29 S exit toward Malvern
- 4. Turn right onto PA-29 S/S Morehall Rd
- 5. Take the 1st right onto Lindenwood Dr
- 6. Make first right into Valleybrook Corporate Center
- 7. Bear right and follow sign to 101 Lindenwood Drive into office complex
